#### Charitable Donation Scheme – Tax Refund (Envelope Collection)

Last year our parish benefited to the tune of €30000 from this scheme.

As a Revenue approved registered charity the parish can claim a tax refund/benefit in respect of all moneys contributed by participating parishioners once the **cumulative contributions**, in any calendar year, are greater than  $\pounds 250$ . That  $\pounds 250$  entitles the parish to a **tax refund of**  $\pounds 112$  from Revenue – therefore your contribution is worth  $\pounds 362$  to the parish.

<u>Put more simply each  $\notin$ 5 is worth  $\notin$ 7.25 to the parish.</u> However for us to get that refund You must sign up to participate in this envelope scheme. This can be done by calling to the Parish Office during weekday mornings or going to the sacristy and speaking with the priest after any mass.

We would like to say **Thank You** to everyone who is currently participating in the scheme and hope that more of you will now take the next step and sign up - it is one of the few "free money" schemes still being promoted by Revenue/Government.
